

Letter of Bali administration

In a letter to the Indonesian Ministry of Health, Bali's provincial administration makes clear: We reject the Inter-tabac ASIA trade fair, it violates laws and regulations of the province of Bali.

Here is the (unofficial) English translation of the letter:

Referring to the letter the Chairman of the National Commission on Tobacco Control Number: 020/KOMNASPT/SK/I/2014 dated January 22, 2014 regarding the concerns about the International Trade Fair for Tobacco Products and Smokers (Inter-tabac) ASIA 2014 in Nusa Dua, Bali, we hereby inform you that Bali Provincial Government categorically rejects Inter-tabac Asia event that is planned for 27th to 28th February 2014 in Bali, with the consideration that Bali does not include tobacco producing provinces and has law No. 10 of 2011 dated November 29, 2011 on no Smoking Areas (KTR).
